## Who is The Consumer?

A physically disabled person determined by the Department of Health and Senior Services (DHSS) to be eligible to receive consumer directed services.

An eligible consumer must:

- be at least 18 years of age
- have Missouri Medicaid coverage
- be able to direct his/ her own care
- Meet the level of care requirement set by DHSS

**Access will do the rest for you!**

## Personal Care Attendants (PCA)

*Personal Care Attendants are hired by The Consumer to help with home and community based tasks.*

**“Encouraging extended independence... Putting privilege and advantage where it belongs”**

Examples of activities that the Consumer may direct the PCA to do may include:

- **Cooking meals**
- **Washing dishes**
- **Bathing and grooming**
- **Dressing and undressing**
- **Laundry**
- **Assisting with medications**
- **Transportation and shopping**

## PCA qualifications:

- MUST NOT be Consumer's SPOUSE
- 18 years or older
- Meet physical demands required to perform specific tasks
- Agree to maintain confidentiality and adhere to HIPPA Policy
- Be emotionally mature and dependable
- Must have a desire to help people with disabilities
- EACH PCA will be subject to background screening

Personal Care Attendants will be paid up to **\$11/ hour** for services provided to The Consumer!
